The specific aims of this proposal are to employ genetic and molecular strategies to conditionally delete Familial Alzheimer's disease (FAD)-linked mutant transgenes in specific cell types of the Central Nervous System in order to explore the effects of this manipulation on Abeta deposition.

Novel Soluable Gamma-Secretase Modulators; Steven Wagner; University of California, San Diego.

Many investigators have explored Gamma-secretase modulators (GSMS) as ways of affecting Abeta production and therefore interrupting the earliest stages of Alzheimer's pathology. One reason for the lack of success in this area has been that earlier GSMS were insoluble. We propose to synthesize a photoaffinity probe based on the most potent Soluble Gamma-Secretase Modulator compound that we have developed which will be used in photolabeling and affinity capture experiments in order to provide direct evidence for the molecular target of these AGSMs. These photoaffinity-labeling and affinity capture studies using the SGSM photoprobe will be carried out in collaboration with Dr. Rudy Tanzi using various reconstituted and well characterized γ -secretase assay systems as described previously.

Effect of Bexaratene on Abeta in Alzheimer's disease; Washington University, St. Louis; David Holtzman.

This will confirm and extend results from the laboratory of Gary Landreth at Case Western Reserve University whose work on bexarotene suggests it may be particularly effective as a treatment for Alzheimer's disease.

Here we will optimize these three inhibitors by screening a novel library of compounds based on their structure. We will determine whether the novel inhibitors prevent development of amyloid pathology and alter APP process in AD mice in absence of toxicity. These studies should result in one or more novel ACAT inhibitors with the potential to prevent and treat AD.

In addition, cleavage of the APP protein by a-secretase gives rise to the production of the secreted alpha cleaved APP fragment (sAPP α), which has been shown to have neuroprotective properties. A recent study has shown that when synthetic sAPP α is administered to mice following experimental head trauma it appears to be protective, reducing neuronal death and axonal
